1. Welcome

Dorothee Kurz opened the thirteenth ordinary annual General Assembly of Ingenieure ohne Grenzen Schweiz at 15:05 by welcoming the participants. This year too, the meeting has to be held online due to the ongoing situation of the Covid-19 pandemic. This meant a slightly different set of house rules to be reviewed at the start:

- Microphones are all on mute except for the person presenting.
- Comments and questions can be posed via the chat (unless communicated differently).
- All cameras should be switched on if possible, in order to create a more personal setting.
- Votes: for votes and elections, the button "Raise Hand" is to be used by all members.

6. Annual Report 2020

The annual report for 2020 was sent to the invitees on 04.03.21 via email. The currently ongoing projects are the following:

Current projects:

- Gradačac, Bosnia and Herzegovina (BIH001): Construction of a social housing community for socially disadvantaged women
- Paraguay (PRY001): Drinking water supply
- Nepal (NPL004): Hospital extension for gynecology and obstetrics
- Water for IAPS (KEN002): Improving water supply of school to enable all year operation

The project leaders or members of the currently running projects are presenting the project status. The evaluation projects are presented later in the General Assembly when looking into 2021 (Outlook). The project updates are not repeated here, they can be found in the annual report. With the exception of the project in Gradačac (Bosnia), which provided in-depth insights into the legal set-up of the project:

Social accomodation in Gradačac, Bosnia - Christian da Maddalena, Eric Carrera

One of the two project leaders Christian de Maddalena presents the project status (see also the annual report 2020). Despite the corona crisis, the project reached an important milestone, the construction of the house could be started in November 2020. Some impressions of the construction site are shown:








The start of constructions naturally entails bigger amounts of project expenditures (see financial report), which is taken as an opportunity to explain the legal set-up of the project once again. The project team made a graphical explanation of the setup with collaborators and partners of the project:





As presented at the last General Assembly, the Bosnian foundation Nas Izvor was founded by IngOG+ in order to guarantee the execution of the project and the operation of the social institution later on. IngOG+ as the founder of this local organization defined the statutes of Nas Izvor. The only purpose of this foundation is to plan, construct and operate the house. IngOG+ has the right to constitute the board of Nas Izvor. At the moment, the board of Nas Izvor consists of three IngOG+ members – which means, that the control of the project finances is in the hands of IngOG+. The money that IngOG+ raises for this project is donated to Nas Izvor, which is obliged by its statutes to spend the money on the construction and operation of the house. There is no legal obligation for IngOG+, the foundation Nas Izvor in Bosnia is independent.

The house is built on land owned by Hazima Smajilovic, the initiator of the project. The building right (Baurecht) of Nas Izvor was agreed upon by a contract with Hazima over the next 30 years for a minimal fee. During these 30 years, the house can only be used for the project purpose. After the 30 years, the contract can be renewed with the family Smajilovic (still, the purpose of the house remains the same).

Contracts and agreements with other partner organizations are also made or are still in discussion.

7. Financial Report 2020

Having presented the financial highlights of 2020 and comparisons against the achievements of the previous year (2019), the treasurer Lukas Dössegger confirmed the closing balances of the organisation's accounts for 2020.

One correction came from project leader of the KEN002 project, Jean Randhahn: KEN002 spent CHF 6'024 instead of 2'184. This was only listed incorrectly in the presentation, in the annual report the figures are correct.

Another question was raised by one member on why the members ship fees can not be divided by CHF 100. The explanation lies in possible splitting of the membership fees over the year (monthly fee) and the fees to be paid to PayPal. Furthermore, students pay CHF 30 instead of 100.

Dorothee and Lukas have both been very committed to the board and IngOG+ in general and have given much of their time to the association. We thank you both very much for your commitment and the great time in the board during the past year(s)!

10. Elections 2021

President

Andreas Wende runs for the position of President of the organisation, after around three years of involvement in IngOG+. Andreas holds degrees in Architecture, Business Administration, Real Estate



Management and Sustainable Development with studies all over the world. Since around one and a half year he is project leader of the hospital extension project in Ratnanagar, Nepal (NPL002).

Projects in Evaluation phase:

- Nicaragua (NIC001): Construction of a bridge over a flooding river
- Water supply Khema (IND002): Improvement of water supply during winter months
- Heating system Lahaul (IND003): Implementation of an efficient heating system in a Himalayan school building
- Puente Tierra, Chile (CHL001): Construction of a community center for the indigenous Mapuche community Millanao Ancaten

IngOG+ as association in 2021

The freshly elected president Andreas Wende presents the outlook of IngOG+ as an association in 2021. First of all, the board aims for a revival of the "Vereinskultur" in this year – after over a year of remote working, marathons of Zoom-meetings and lots of cancellations, it is the goal to get back to a normal, social association culture as far as possible: beside regular meetings and workshops, following events are planned (of course, everything according to the rules regarding covid-measures):

- Hike
- Summer party
- Lunch-Seminar in Autumn
- Christmas Dinner
- Christmas Action

Another important point of the organization this year will be to get swiss legal advice on contracts with third parties and partners. In the future, partnerships that involve larger amounts of money will be secured contractually. An appointment with a lawyer has already been set. Concerning this point, one member (Carina) raised the question, whether we should aim to find voluntary lawyers joining IngOG+ as members, or whether we want to only get external help. The board reserved some financial resources for legal advice, but if members know dedicated lawyers that would like to contribute to IngOG+, this would be highly welcome. In general, it is aimed to get a more members with different backgrounds.

The other goals of the association in the upcoming years are the following:

- Strengthening process quality and project controlling (Project guidelines)
- Internal restructuring for process simplification
- Increase media outreach and public presence of IngOG+
- Local activities and support in Switzerland
